Late Payment Fee	\$25.00	Monthly fee for late payment(s)
Insufficient Funds Fee	\$40.00	Fee for insufficient funds including but not limited to a bounced check or an electronic transfer that fails due to insufficient funds in the customer's account
Credit Card Payment	2.95%	Payment made by credit card if the following are met: (A) Must not exceed 3% of the amount charged; and (B) The awardee must offer an alternate form of electronic payment, such as direct bank to bank transfer, with no added fee for the customer
